A \$\$ Note from the Treasurer

During 2006, the Board of Directors elected to have a reserve study done of our community. This is an in depth look at the common elements owned by the Association, their remaining effective life, and there future cost to replace.

The goal of such a study is to aid in planning so that we can meet those financial targets as they come up. I always hate to be the bearer of bad news, but it would appear that the Association's reserves will fall a bit short of our responsibilities at their current pace, and therefore the Board feels that it will be necessary to raise dues for 2007.

The largest expense on the horizon is the complete grinding and resurfacing of the parking pads in the community. This year the County surprised us by repaving the streets in the neighborhood right through the Memorial Day weekend, after telling us that we were on the schedule for 2007.

Our goal had been to piggyback with the County contractor and try to have the entire community done at once. Sadly, we may not have been able to afford that even if we had been given the time to contact the contractor. The cost to properly resurface our parking pads will be

roughly \$110,000 which is more than our current reserve balance.

According to the reserve study though, we have about 5 years of useful life in the parking pads.

To avoid living with the striking contrast in appearance for the next 5 years though, the Board is looking into having an asphalt seal coating applied to the parking pads in late 2006 or early 2007. That cost should be far more reasonable in the \$5,000 range and should keep the appearance of the community pleasant.

Beginning to increase dues now should allow us to catch up with our reserve requirements so that we can afford the full resurfacing in 2011-2012 without completely emptying the coffers.

Monthly Assessment Payments

On a separate note, I'd just like to express my positive feelings toward automated bill payments.

This is something I've personally switched over to through my credit union over the course of this year.

I set up my payments online ahead of time and when the time comes, my credit union either wires or sends a check to the party being paid. Many of my bills are now paid this way on a recurring basis...

including my Carter's Cove Homeowner's Association dues.

It was brought to my attention that many people may not be aware that this is a possibility for them so I thought I'd mention it as something I'd encourage you to look into. Since February when I set this up, I haven't had to lift a finger to pay my HOA dues. Every month a \$35 check (with my HOA account number on it) is mailed directly from my credit union to Howard Property Management, Inc. and I haven't missed a payment or incurred any late fees since.

Common Area Tree Removal and Replanting

Beginning on Monday, September 25th, MainScapes will begin the process of removing the designated common area trees that have been marked and grinding the stumps. The removal should take approximately two days. If your reserved space is near a common area fruit bearing tree slated for removal, please park in another space to allow the contractors and their equipment easy access. Since this is a temporary project the Board hopes that finding alternative parking for a short period during the day will not be an issue.

On Wednesday, September 27th, the planting of all new trees will begin. This may take a few days as well. These trees will be staked and mulched by the contractor. Please advise your children not to play near the trees. They need to opportunity to become established. Each new tree cost approximately \$400. If your child is found to be disturbing or damaging a new tree, you may be asked to pay for a replacement.

Everyone needs to be vigilant at all times. Report problems of this nature to the property manager directly at 410-33-8608.

Dumpster Weekend—October 21 and 22

The Board has arranged for Howard County to provide dumpsters to the Carter's Cove community the weekend of October 21st and 22nd. This is a free service provided by the County. However, the clean up after the dumpsters are removed is an expense that the Association incurs.

When residents pile items way above the top of the dumpster, or leave items next to the dumpster, the Carter's Cove Association must pay a contractor clean-up fees. Please be sure all items are placed **IN** the dumpster! Break down larger items so more can fit in the dumpster.

- Forcing children to play in the only designated play area (Tot Lot)

As an HOA member what can I do to help?

- Attend the HOA meetings to stay abreast of the issues that affect your community
- Frequently review the minutes (and other information) on the carterscove.info website
- When you identify problems also present solutions
- Volunteer to help in any capacity
- Teach your children to be respectful of adults
- Teach your children to clean up their trash
- Pick up trash instead of walking around or over it
