Finance Committee

The Homeowner's Association (HOA) fees are used to keep Carter's Cove community looking its best. As you are aware HOA fees and guidelines were provided at closing when Carter's Cove residents initially purchased your homes.

The following is an itemization of some of the collection charges the Attorneys we retain charge individuals who do not pay the monthly HOA fees:

Initial Demand Letter (retainer clients only)	No Charge
Lien Warning Letter (Notice of Intent to Create a Lien)	\$175.00
Statement of Lien (File & Release)	\$ 75.00
Foreclosure/Suit Warning Letter	\$100.00
Draft and File Civil Suit (District Court only)	\$325.00
Confessed Judgment Notes	\$100.00
Bankruptcy Proof of Claim	\$175.00
Balance Due Letter	\$25.00

Also if individual homeowner fees are not paid and the account goes to the attorney and attorney fees are incurred the attorney's fees will be paid first.

Example: If homeowner pays \$500, with the HOA fees totaling \$1000.00 the \$500.00 will be applied to any attorney fees first before HOA fees balance will be reduced.

To avoid the above fees you need to pay your dues on time. If you are behind in your dues please call Crest immediately. Residents who are more than one month behind will be turned over to the lawyers for collection.

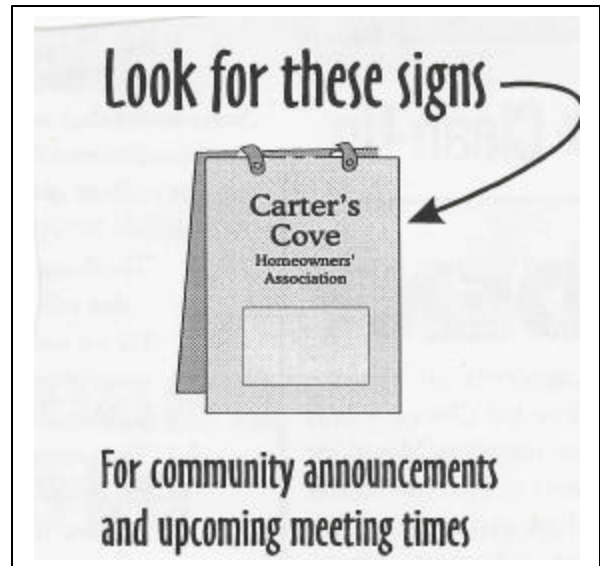

Trash and Recycle Pick-Ups

This is another reminder of the trash and recycle pick-up dates and times. Many of you are new to our community and should know about the trash and recycle pick up times. The trash is picked up on Friday mornings between around 6 a.m. Trash should be placed at one of the islands in the parking areas on Thursday evenings. **Because we want to keep our community looking its best, please do not put your trash out before 6 p.m.** Note: Grass clippings and trimmings from bushes and hedges are picked up on recycle days. Please do not put them out earlier or on trash days. Recycles should be placed in the same location on Tuesday evenings (after 6 p.m.) to be picked up on Wednesday mornings, around 6 a.m.
